a) Crumbling Pavement

a) Fir Tree Garage
Cllr Myhill reported that tree planting had now taken place.

b) Footpath Goylands to Millview Close

Cllr Price and Cllr Norris brought this matter to the attention of the Council. Some work has taken place and a tarmac section is being laid on the Goylands side of this path. Cty Cllr Williams will speak to the contractors to establish what is happening.

c) Chapel Road Sign

No work has been done on this. The Clerk will chase this up with PCC.

d) Railway – Cwmbach

Cllr Hamer reported that Network Rail have done some work by Cwmbach Bridge and have left a lot of mess on the embankment. The Clerk will speak to HOWLTA regarding this. Cllr Morgan also brought up that the fence is not stock proof.

e) Register of Member's Interests

Cllr Price read out an article from a newspaper informing members of new legislation coming into force in May to publish Accounts and Registers of Members Interests on Town Council websites. The Clerk is aware of this and will seek clarification and place this matter on the agenda for the next meeting.
