DT 73/15 Correspondence

a) Powys County Council Planning - Cilgynfydd Plantation

Letter informing members that a Planning Contravention Notice to inform the owner of PCC's intention to take enforcement action at this site has been issued. The landowner has 3 weeks to respond to this notice. (Letter received on 17th July 2015.)

b) Edwina Hart AM – Trunk Road A483 Howey

Response from Minister as follows:

“Thank you for your email of 29 June regarding the A483 at Howey. We continually monitor the trunk road network to identify any road safety improvement measures. Whilst we await the formal police report relating to the recent collision at Sunnyhaven Park, initial information received from the police suggests that speed was not a contributory factor”

Resolved: Clerk to write to the Minister pointing out that the installation of barriers may well have prevented this incident.

d) L Rainbird
