Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.

My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

Auditor General's report

Audit opinion - Unqualified

On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters arising and recommendations

The Council has carried forward reserves of £26,890, compared to its annual precept of £12,232. The carried forward reserves include general reserves of £11,250 and earmarked reserves of £15,740. Notwithstanding the impact of COVID19 on the Council's activities, both the annual precept and the closing balances have been steadily increasing for a number of years. The Local Government Finance Act 1992 only allows the Council to set a precept to fund planned expenditure and requires it to take its reserves into account when setting the precept. To ensure that it sets a lawful precept, we recommend that the Council reviews its reserves (including its general reserves) and its plans to apply these reserves when setting its next budget and precept.

There are no further matters I wish to draw to the Council's attention.
